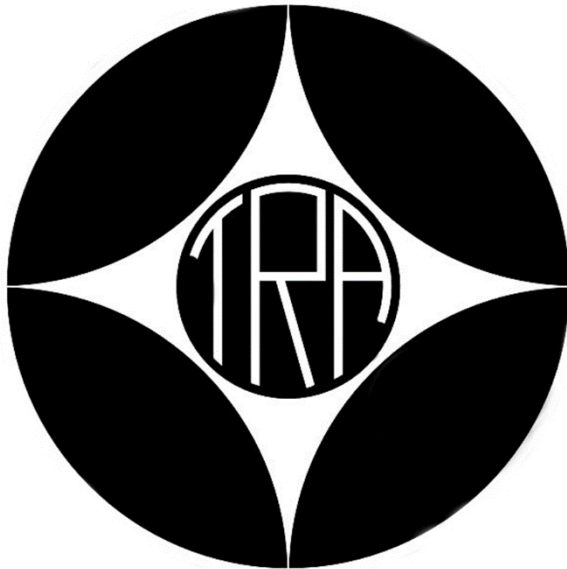

**Product Certification Scheme:**
