### M12.0 Call to Order, Welcome, Introductions

Update June 16, 2015 - Alternate Chantal Guy of SCC, provided the



following update. 5\_v1\_2015-06-16.pdf It was noted that the SCC ORD task group provided an update to NPSAC at a May 2014 meeting in Ottawa, which was endorsed in principle. The "Guidelines for the Development and Maintenance of Other Recognized Documents (ORDs)" was published in June, 2015. SCC has since begun outreach to RAABs to sign MOUs. SCC to present MOU at upcoming meeting of CACES on June 18, 2015. MOU with CACES is targeted for completion by Sep 1, 2015. Other RAAB outreach (incl. CACEE) may be expected thereafter. Other SCC updates were also included as reference.

- ACTION M11.3 (Open) Regulatory members were requested to consider whether there is a committee currently in existence that may serve a similar role of more senior energy efficiency policy makers, similar to NPSAC. **Update June 16, 2015** – Guest Brian Alford, Chair of NPSAC, provided a short overview of NPSAC, noting the "Policy" vs. "Technical" focus and that one of the current NPSAC priorities is to seek harmonization of Codes and Standard across Canada, to lower barriers to transport of goods and services. After a round of discussion, it was agreed that CACEE should continue the effort to identify a suitable Committee/Council that could serve as a senior Policy forum, similar to how NPSAC interacts with CACES. The Canadian Council of Ministers of the Energy or the Environment was suggested as 2 potential groups. Brian offered to forward an overview of NPSAC, for reference by CACEE. Donald to coordinate discussions with other regulators to further this item in advance of the next meeting of CACEE.

**M12.7.1** Status of the Regulatory Cooperation Council (RCC) in regards to Harmonization of energy efficiency standards and regulations.

Alternate Jamie Hulan provided the following presentation to CACEE attendees, which provides a status update of the DOE-NRCan Work Plan & Regulatory Partnership Statement (RPS) released on May 28, 2015.



It was noted that the following meetings will be driven by the RPS and will take place on an annual basis: 1.High-level governance meeting (stakeholders included) expected in spring 2016, 2.Technical expert group meeting (stakeholders included) shortly after the high-level governance meeting; and a schedule of meetings will be distributed to stakeholders once details have been confirmed.

Wrt Joint information gathering; NRCan and DOE will still need to undertake independent regulatory development processes – with unique data requirements. Work Stream B is about coordinating information gathering to ensure NRCan and DOE are filling the right information gaps to characterize the Canada-U.S. market. Departments will share details on intended outcomes of information collection activities to ensure they meet respective needs.

During a round of discussion it was suggested that NRCan either consider CACEE as a forum for input to the RCC process, or as a source of members for its proposed technical expert group meetings.

Guest Bruce Rebel provided a follow-up presentation to attendees, in support of the letter of June 10, 2015 forwarded to Chair Dona Dodge and attached to the meeting agenda, entitled; improving the Regulation of Energy Efficiency in Canada. The presentation was not available at the time of release of these draft minutes. As part of the discussion, CACEE was requested to work towards greater harmonization and alignment of energy efficiency standards, test procedures, and labeling regulations across Canada and North America. In addition more regularity to CACEE meetings may allow for proactive review and response to evolving issues.

ACTION M12.3 (Open) – ToR task group to further consider opportunities to incorporate principles promoting harmonization, etc., as part of ToR update effort.

- M12.7.2 Current Energy Efficiency Regulatory Initiatives, by Province/Territory and Federal Government, outlining the following: (1) existing equipment regulations that have taken effect; (2) proposed new standards; (3) building code update; (4) government initiatives to support market transformation for codes and standards; (5) relevant utility/agency DSM efforts; (6) other energy efficiency initiatives government, utility, agency, and private sector. Where noted written reports were provided. Verbal reports provided may be incomplete, and it's suggested that the reader contact the jurisdiction directly for any updates or clarifications.
- NRCan (Jamie) It was reiterated that Amendment 13 is currently with the
  decision makers within government, and staff have no further details available.
  The pending Federal election announcement may impact on the timing of a
  decision. The objective of Canada-US harmonization remain s in effect.
- Alberta (Brian) Alberta has recently elected a new Provincial government. It is still in the early days in Alberta for developing a climate change strategy. The Alberta government will be undertaking consultation with Albertans and specific stakeholders over the summer with the view of releasing a revised strategy before the COP meetings in Paris. - Newfoundland & Labrador (Leanne) No report available.

**Nova Scotia (Bob)** – A new government was elected approximately 1.5 years ago. *Post Meeting Written report;* 

We completed a review of our electricity system and released the final report in spring 2015. The report is available at <a href="https://www.novascotia.ca/electricityfuture">www.novascotia.ca/electricityfuture</a>

We are currently finalizing amendments to the Nova Scotia Energy-efficient Appliances Regulations which we plan to implement in Fall of 2015. This will harmonize with Federal Standards Amendment 11, specifically:

- Electric motors
- Residential gas boilers
- Residential oil boilers
- *Dry-type transformers*
- Large air-conditioners and heat pumps
- Commercial self-contained refrigeration
- General service incandescent reflector lamps
- Addition of C653-13 Photometric performance of roadway and street lighting
- Updates to how efficiency standards are referenced, to capture future versions of the standard without needing to amend regulations
- General clean up of the regulations
  - New Brunswick (Heather) No report available.

- Prince Edward Island (Andy) PEI has recently elected a new government.
  Direction pending for Energy/Environmental policy. Industry concerns of EE
  harmonization on products and systems is resonating. Utility DSM plan is in
  progress. There are no EE equipment regulations in place (or planned).
- Quebec- (Jean-Philippe)
- Post Meeting written report The province of Québec is currently in the
  process of updating its energy policy (2016-2025). This document is planned to
  be adopted by the end of 2015. Québec is currently working on establishing the
  requirements to update its appliances regulation. Harmonising the requirements
  with principal commercial partners is an important aspect of the project.
- Ontario (Senka) V Ontario has been updating its EE regulations fairly regularly. Next proposed amendment is in process. 20 Products posted for Public Review – Response date by July 6. Proposing to align with US DOE 10 CFR regulation for 5 products. A 30 TWh energy savings target proposed by 20132 as part of 2013 Long Tern Energy Plan.
- Manitoba (Rathan) V Few items have changed since the last report;
  - MOU to harmonize energy efficiency product regulations to align with Ontario where possible.
  - Manitoba is developing a white paper which would include a framework and strategy for developing and implementing minimum energy performance standards in Manitoba for energy-using products.
- BC (Nathaniel) No report available.
